October 8, 1925 - November 20, 2017

Ann Cherry Hutchison, 92, of Venice, FL, passed into glory on Nov 20, 2017.

Annie Court was born October 8, 1925 in Chadderton, England, to Effie (Butterworth) Court and Harry Court. Ann married William Karl Cherry during WWII and moved to the U.S. with him to live in Wilmerding, PA. Together, they raised three sons.

Ann was active professionally and in various civic and creative endeavors throughout her life. She managed the East Burroughs Insurance Agency, worked for the Occupational Health Foundation, was a Past Matron of the Order of the Eastern Star, a life-long Methodist, and a member of the Embroiderers' Guild of America and the American Needlepoint Guild. She also held multiple positions on the Women's Association at her beloved Ridgeview Park and at the Village on the Isle.

After the death of her first husband Karl in 1984, she married Robert Hutchison of Squirrel Hill, PA, on March 30, 1996. Ann and Bob retired to Venice, FL, where she continued to enjoy stitching, painting, duplicate bridge, and loving three generations of both families. Bob predeceased her on December 31, 2012.
